 - 1. Marina Floating Pier Project The electrical and piping work is being completed. It appears the May 1, 2010 deadline will be met.

- 1. Chad Austin, 409 W. Foster Street addressed the council regarding the location of the Senior Center to the Franklin Energy building on Foster Street. The area has families with children and pets living in it. Some concern over traffic and parking. The neighbors are going to meet with the Senior Center to express their concerns. Mayor Huebner invited Mr. Austin and neighbors to meet with him to discuss this further.
- 2. Joe Zankl, Port Hotel addressed the council on the upcoming St. Patrick's Day, parade being held on March 17, 2010. Zankl invited the council members to walk in the parade.

COMMITTEES

A. Finance and License Committee

 Update On 2008 Borrowed Funds-Alderman Hudson reported on the improvements for the Park and Rec. Department heating and ventilation system. A memo by Mary Bley indicates the City has approximately \$250,000 remaining in the 2008 Borrowed Funds. We have until March 5th to expend the monies in this fund to get to the \$215,000 amount. The improvements will total approximately \$55,000. With the payment of this

- project, the amount of borrowed funds would bring us below the \$200,000 level and meet the bond resolution requirements.
- 2. Consider 4th Of July Fireworks Proposal- Alderman Hudson reported on the previous fireworks company, Mad Bomber, who had a 3 year agreement with City and has now expired. This company has not submitted a new bid. The current bid being considered has been submitted by J. and M. Displays, and is a 1 year contract. The budget is \$13,500 and this submitted contract is within the budgeted amount. MOTION MADE BY ALDERMAN HUDSON, SECONDED BY ALDERMAN LARSON TO APPROVE THE CONTRACT WITH J. AND M. DISPLAYS CONTINGENT UPON REVIEW OF CONTRACT BY ATTORNEY EBERHARDT. Motion carried unanimously.

A. Plan Commission

- Ordinance 2010-6 (Revise Portions of Chapter 20.29, Sign Code Relating To Business Signs) 1st Reading- MOTION MADE BY ALDERMAN VOLLMAR, SECONDED BY ALDERMAN BECKER TO TABLE THIS REVISION TO THE SIGN CODE. Motion carried unanimously.
- Ordinance 2010-7 (Amend Zoning Code To Create A Land Use Transition Overlay District) 1st Reading

 — Planner Tetzlaff reported on the ordinance meeting the requirements of the smart growth/comprehensive plan. This will require a conditional use approval for the properties involved.
- 3. Ordinance 2010-8 (Rezone Parcels Of Land Along Freeman Drive From B-2 to RM-2) 1st Reading- Planner Tetzlaff reported the ordinance being drafted is to address 3 parcels which are apartment buildings on Freeman Drive that are currently zoned B-2 and are non-conforming, re-zoning them to RM-2 bringing them into conformance.
- 4. Ordinance 2010-9 (Rezone The Primary Environmental Corridor With A Conservation Protection Overlay) 1st Reading-Planner Tetzlaff reported on the mapped environmental corridors by Southeaster Wisconsin Regional Planning Commission (SWRPC) of the bluff area north of Jackson Street, the Valley Creek ravine and Ulao Creek Watershed (VK Development lands). The comprehensive plan requires these areas be mapped and rezoned with a conservation overlay.
