

**MINUTES

1. Roll Call- Members present were Aldermen Dave Larson, Doug Biggs and Bill Driscoll. Also present was City Administrator Mark Grams.
2. Approve Minutes Of Previous Meeting- Motion made by Alderman Biggs, seconded by Alderman Driscoll to approve the minutes as presented. Motion carried unanimously.
3. Consider Original Class A Beer And Class A Liquor License Application- Motion made by Alderman Biggs, seconded by Alderman Driscoll to recommend approval of an Original Class A Beer and Class A Liquor License for Reichert Studios, LLC, d/b/a Chocolate Chisel- John Reichert, agent. Motion carried unanimously.
