**AN ORDINANCE ANNEXING TERRITORIES TO
THE CITY OF PORT WASHINGTON, WISCONSIN**

The Common Council of the City of Port Washington, Wisconsin, do ordain as follows:

SECTION 1. Territories Annexed. In accordance with sec. 66.0217(2) of the Wisconsin Statutes and the Petition for Direct Annexations filed with the City Clerk on the-

3 day of, May, 2016 signed by owners of all of the land in area and all of the electors in the territories, the following described territories in the Town of Port Washington, Ozaukee County, Wisconsin, are annexed to the City of Port Washington, Wisconsin:

See legal description attached hereto as Exhibit A

SECTION 2. Effect of Annexation. From and after the date of this ordinance the territories described in Section 1 shall be a part of the City of Port Washington for any and all purposes provided by law, and all persons coming or residing within such territories shall be subject to all ordinances, rules and regulations governing the City of Port Washington.

SECTION 3. Temporary Zoning Classification. The territory to be annexed to the City of Port Washington by this ordinance is temporarily zoned as follows, pursuant to sec. 66.0217 (7) of the Wisconsin Statutes: AG Agriculture Lands District.

SECTION 4. Ward and Aldermanic District Designation. The territories described in Section 1 of this ordinance are hereby made a part of the 4th ward and 4th aldermanic district of the City of Port Washington, subject to the ordinances, rules and regulations of the City of Port Washington governing wards.

SECTION 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.


SECTION 6. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.

EXHIBIT A

Legal Description

A parcel of land located in the SE $\frac{1}{4}$ and SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 31, Town 11 North, Range 22 East, Town of Port Washington, Ozaukee County, Wisconsin described as follows: Commencing at the East $\frac{1}{4}$ corner of said Section 31; thence S02°10'50"E - 1327.81 feet along the east line of said SE $\frac{1}{4}$ of Section 31 to the point of beginning of lands to be described; thence continuing S02°10'50"E - 293.79 feet along said east line; thence S34°06'05"W - 101.39 feet; thence S02°10'50"E - 288.96 feet to the south line of the north $\frac{1}{2}$ of the south $\frac{1}{2}$ of said SE $\frac{1}{4}$; thence S87°09'21"W - 1817.07 feet along said south line; thence N51°04'48"E - 903.15 feet; thence N87°10'57"E - 108.62 feet; thence N51°04'48"E - 225.00 feet to the north line of the SE $\frac{1}{4}$ of said SE $\frac{1}{4}$; thence N87°10'57"E - 864.33 feet to the point of beginning. Said parcel contains 20.94 acres.
